VISA_CLASS	Type of application submitted for processing. CW-1 refers to applications submitted by, or on behalf of, employers seeking certification to employ foreign workers on a temporary basis.
SUBMITTED_DATE	Date the applications was received at the National Processing Center.
CASE_STATUS	Status associated with the last significant event or decision. Valid values include "Certified – Full," "Certified – Partial," "Denied", and "Withdrawn."
TYPE_OF_APPLICATION	Category of requested employment. Valid values include "New employment" and "renewal of approved employment"
CERTIFICATION_BEGIN_DATE	Actual date granted to an employer indicating when the need for the foreign workers to perform agricultural services or labor is expected to begin.
CERTIFICATION_END_DATE	Actual date granted to an employer indicating when the need for the foreign workers to perform agricultural services or labor is expected to end.
EMPLOYER_NAME	Name of the employer requesting temporary labor certification.
TRADE_NAME_DBA	If Applicable, the "doing business as" name of employer submitting labor condition application.

TOTAL_NUMBER_OF_HOURS	Total work hours offered each week.
HOURLY_WORK_SCHEDULE_AM	Proposed Work Schedule Start Time.
HOURLY_WORK_SCHEDULE_PM	Proposed Work Schedule End Time.
BASIC_RATE_OF_PAY	Rate of pay offered.

OVERTIME_RATE_FROM	Overtime Rate Starting Amount (if applicable).
OVERTIME_RATE_TO	Overtime Rate Ending Amount (if applicable).
PAY_RANGE_UNIT	Unit of pay. Valid values include "Hour," "Week," "Bi-Weekly," "Month," "Year," or "Piece Rate."
SUPERVISE_OTHER_EMP	Y = Supervisory Position; N = Not a Supervisory Position.
SUPERVISE_HOW_MANY	Number of Employees to Supervise (if applicable).
EDUCATION_LEVEL	Minimum level of education required for position. Variables include "None", "High School/GED", "Associates", "Bachelor's", "Master's", "Doctorate (PhD)", or "Other Degree (JD, MD, etc.)."
